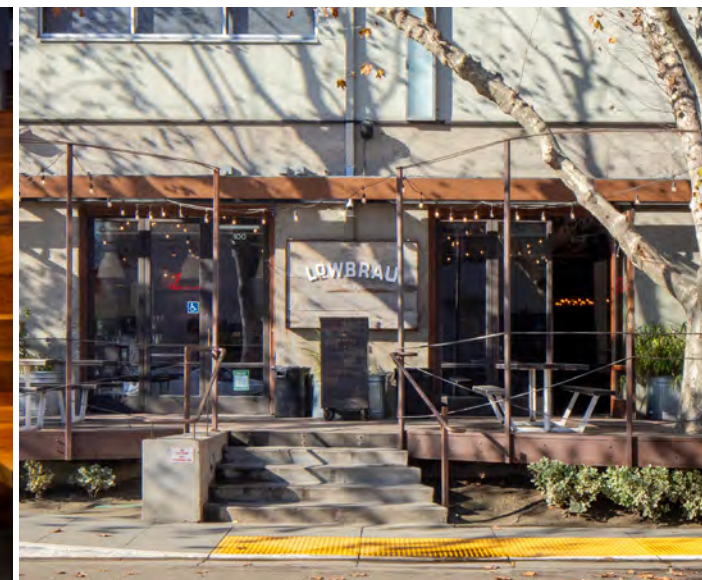

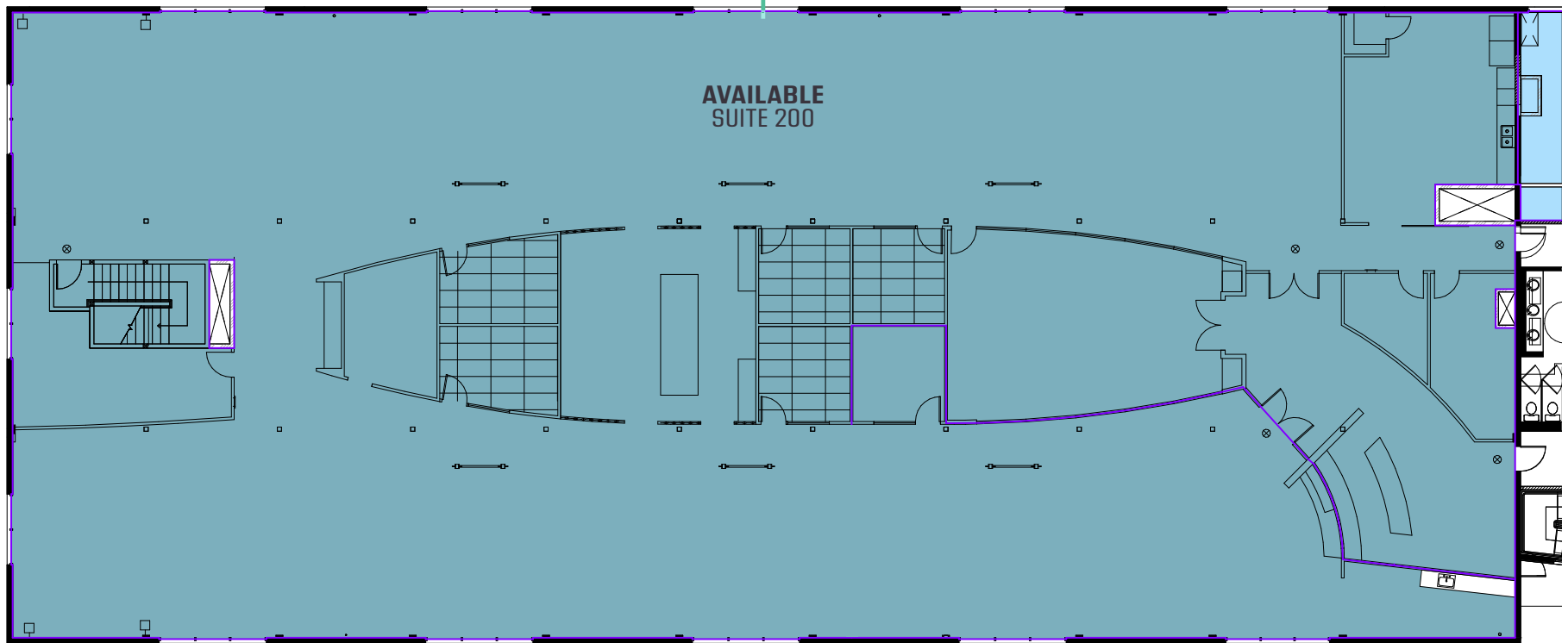

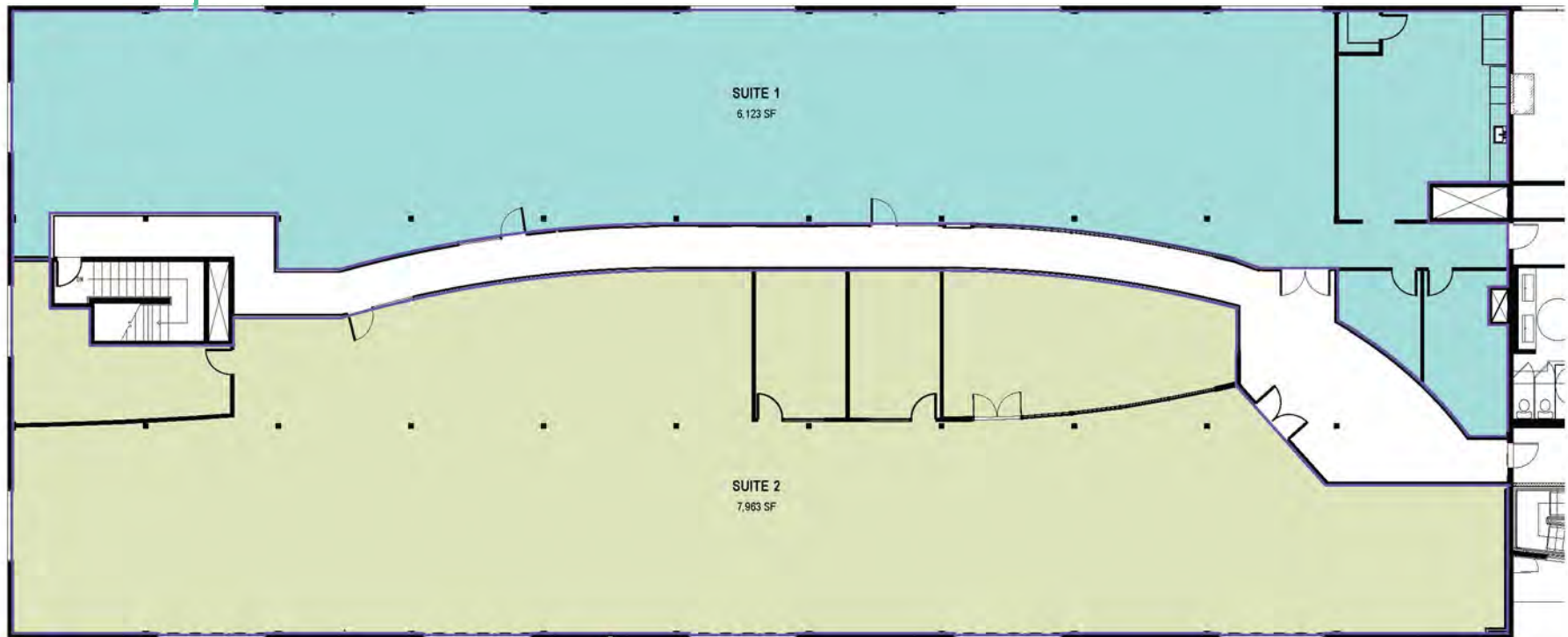

SUITE 200: HYPOTHETICAL DEMISE PLAN

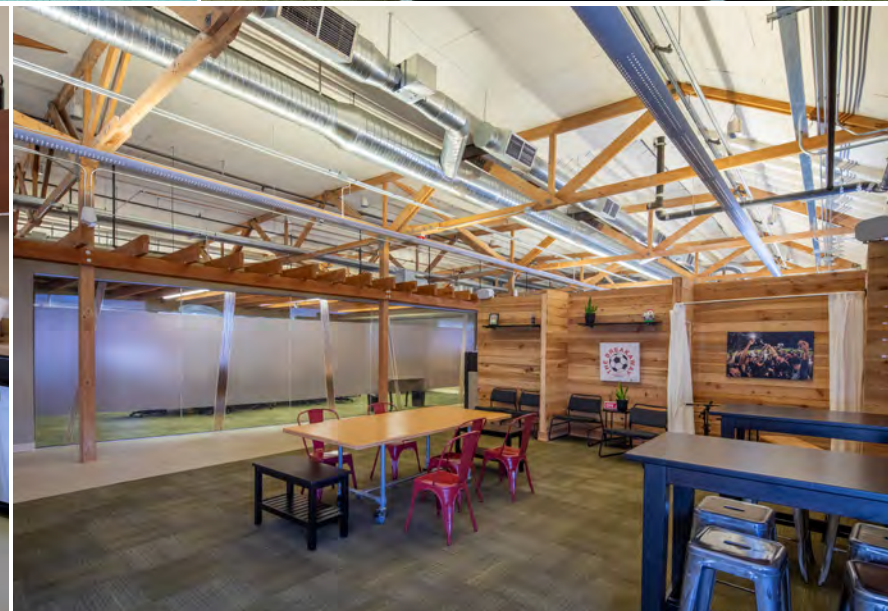
